Violation 1 Item 1

Violation Type: Willful Serious

WAC 296-155-657(1)(a)

The employer did not ensure that each employee in a excavation more than four feet in depth was protected from cave-ins by an adequate protective system.

Upon inspection, four employees were determined to be working in and near a trench/excavation more than four feet in depth in order to install sewer pipes without an adequate protective system to prevent cave-ins at a jobsite in Renton, WA.

When excavations, more than four feet, do not have adequate protective systems to protect against cave-ins, employees injured by a cave-in or engulfment could suffer injuries resulting in permanent disability or death.

Situation not believed to exist any longer. However, if this violation is identified again during future inspections, it may result in repeat or failure to abate violations which may include penalties.

Assessed penalty: \$145,027.00

Violation 1 Item 2

Violation Type: Willful Serious

WAC 296-155-655(3)(b)

The employer did not ensure that there was a safe means of egress from trench excavations.

Upon inspection, four employees were determined to be working in and near a trench/excavation without safe egress at a jobsite in Renton, WA. At the jobsite the ladder did not extend at least three feet above the trench, two separate sections of ladder were lashed together with rope, and the ladder side rails and rungs were damaged and not removed from use.

When a safe means of egress is not provided to employees working in trench excavations, there is no means of safely evacuating a trench in the event of a cave-in and employees could suffer injuries capable of causing permanent disability or death.

Situation not believed to exist any longer. However, if this violation is identified again during future inspections, it may result in repeat or failure to abate violations which may include penalties.

Assessed penalty: \$145,027.00

Violation 1 Item 3

WAC 296-155-655(11)(a)

Violation Type: Willful Serious

The employer did not ensure that daily inspections of the excavation, the adjacent areas, and protective systems are made by a competent person for evidence of a situation that could result in possible cave-ins, indications of failure of protective systems, hazardous atmospheres, or other hazardous conditions.

Upon inspection, it was determined that four employees had been working in or near a trench more than four feet in depth without a competent person on-site to ensure that soil was properly classified before work began, inspect the trench for cave-in protection before allowing employees to have access, and did not ensure adequate access and egress for employees working in the trench.

Employees injured by cave in/engulfment due to no daily inspection by a competent person could suffer injuries resulting in permanent disability or death.

Situation not believed to exist any longer. However, if this violation is identified again during future inspections, it may result in repeat or failure to abate violations which may include penalties.

Assessed penalty: \$145,027.00

Violation 2 Item 1

WAC 296-155-110(2)

Violation Type: Serious

The employer did not develop a formal Accident Prevention Program that was tailored to the needs of the workplace or operation, and to the types of hazards involved.

Upon inspection, it was determined that four employees were working on a construction site and conducting trenching and excavation operations without a formal Accident Prevention Program that was tailored to address trenching and excavation hazards.

Without an Accident Prevention Program tailored to excavation and trenching operations, employees may be unaware of cave-in and engulfment hazards present at the work place that are capable of causing injuries resulting in permanent disability or death.

The following additional correction documentation is required for this violation:

Update your Accident Prevention Program to include requirements contained in WAC 296-155 Part N: Excavation, Trenching, and Shoring and include an updated copy of your Accident Prevention Program with your completed Employer Certification of Abatement.

Violation 3 Item 1

WAC 296-155-110(9)

Violation Type: General

The employer did not ensure that weekly walk-around safety inspections were documented.

Upon inspection, it was determined that four employees were working on a construction site where slips, trips, falls, struck-by and cave-in hazards were present without weekly walk-around safety inspections conducted.

When weekly walk-around safety inspections are not documented, employees are unable to verify if slips, trips, falls, struck-by and cave-in hazards are being identified and corrected increasing the likelihood of injury.

Situation not believed to exist any longer. However, if this violation is identified again during future inspections, it may result in repeat or failure to abate violations which may include penalties.

Assessed penalty: \$0.00

Violation 3 Item 2

Violation Type: General

WAC 296-155-120(1)

The employer did not ensure that where a crew is present, a person with a valid first-aid certificate is available.

Four employees were working on a jobsite where slips, trips, falls, struck-by and cave-in hazards were present without a person with a valid first-aid certificate.

When a person, with a valid first-aid certificate, on a jobsite where hazards exist is not available, employees cannot be afforded timely first-aid, potentially increasing the severity of any injuries.

The following additional correction documentation is required for this violation:

Provide first-aid training to employees and provide copies of training records with your completed Employer Certification of Abatement.

Violation 3 Item 3

Violation Type: General

WAC 296-155-120(2)

The employer did not ensure that crew leaders, supervisors or persons in direct charge had a valid first-aid certificate.

Three employees were working on a jobsite where slips, trips, falls, struck-by and cave-in hazards were present without a crew leader or supervisor with a valid first-aid certificate.

When crew leaders, supervisors or persons in direct charge do not have a valid first-aid certificate, employees cannot be afforded timely first-aid potentially increasing the severity of any injuries.

Situation not believed to exist any longer. However, if this violation is identified again during future inspections, it may result in repeat or failure to abate violations which may include penalties.

Assessed penalty: \$0.00

Violation 3 Item 4

Violation Type: General

WAC 296-27-02105(3)

A company executive did not certify that the OSHA 300 Log is correct and complete.

Upon inspection, the employer provided OSHA 300 Logs that were not certified by a company executive and OSHA 300 Logs did not accurately reflect the amount of hours worked.

When a company executive does not certify that OSHA 300 Logs were correct and complete, injury trends may not be identified and corrected.

The following additional correction documentation is required for this violation:

Correct and certify your OSHA 300/300A Logs for Year 2020 and 2021, and include corrected OSHA 300 records with your Employer Certification of Abatement.

Appeal Rights Inspection: 317970376

For Employers

If you are cited for a violation of Occupational Safety and/or Health rules, you have the right to appeal the citation. **You have 15 working days from the date you receive this citation to appeal.** (RCW 49.17.140(1)) "Working day" means a calendar day, except Saturdays, Sundays and all legal state holidays. Your appeal must be in writing. It may be mailed, faxed, personally delivered or electronically filed. If you electronically file, the Department will send an automated acknowledgement that the appeal was received. **If you do not receive acknowledgement, please ensure you have addressed it to the correct email.** You can also contact the Appeals Program at the number listed below.

For violations classified as serious, willful, repeat serious, or failure to abate serious, an employer must correct the violations by the date listed on the Citation and Notice / Employer's Certification of Abatement form unless a stay of abatement date is requested in the appeal as described on this page. A stay of abatement date means the employer's requirement to abate or correct the hazard is put on hold until the appeal is resolved. All general and repeat general violations under appeal automatically have stay of abatement dates until a final order on those violations has been issued. If you only need an extension of an abatement date, please see the above section entitled, "If you are unable to fix the hazard(s) by the correction due date(s)".

Your appeal must include:

- Name, address, telephone number, and fax number if available of the employer who is appealing, and for the employer's representative, if any, such as an attorney or interpreter.
- Inspection Number (You will find this nine-digit number in the top right corner of this page.)
- Statement explaining:
 - 1. What you think is wrong with the citation and any related facts.
 - 2. How you think the citation should be changed.
 - 3. What relief you are seeking and why.

If you are requesting a stay of abatement date for serious, willful, repeat serious or failure to abate serious, you must also include:

- Each violation and item number for which a stay of abatement date is requested; and
- The reason for the stay of abatement date request.

Note: Employees and/or employee representatives may elect to participate in appeal hearings.

Posting requirement:

You must post your appeal documents (along with this citation packet) until the appeal is resolved. You must also post all other documents related to this appeal.

For Employees or Their Representatives

If your employer is cited, you may only appeal the correction due date(s).

Your appeal must include:

- Your name, address, telephone number, and fax number if available and the same information for anyone who is representing you, if any.
- Inspection number.
- Statement explaining why the correction due date should be changed.
